


IHSS provides homecare for the elderly and persons with disabilities to support them in their own homes and communities, rather than placing them in more restrictive and expensive institutional care settings.











### **Annual Percent Difference by Location**




### **Ethnicity - Congregate Meals**




### **Ethnicity - Home Delivered Meals**



**TANF Timed-Out** 

Families with children living in the home whose parents are ineligible to receive assistance because an adult head-of-household or spouse of a

head-of-household has received federal TANF assistance for total of 48 cumulative months.

Child-Only

Families with children living in home whose parents are ineligible receive assistance.

Total Clients in Welfare to Work

All active CalWORKs adults who have been registered into the Welfare to Work (WTW) program. WTW is the mandatory employment and training program for CalWORKs adults. Clients must register for WTW unless exempted for a condition that prevents them from working. Not all registered WTW clients are actively engaged in the program, as they may be scheduled for activities that have not yet begun, between activities, or

non-compliant prior to sanction.

Subsidized Work and Community Experience

Includes public or private sector employment under the close supervision of the activity provider that helps provide basic job skills and can help lead to eventual unsubsidized employment.

Paying Jobs

Includes unsubsidized and subsidized self-employment, public and private sector jobs.

CalFresh

Non Assistance CalFresh Individuals

Client receives CalFresh assistance but does not receive a monthly cash grant under the California Work Opportunity and Responsibility to Kids (CalWORKs) program or other state-funded program.

All CalFresh Individuals

All clients receiving CalFresh.

Non Assistance CalFresh Caseloads

Household members received public assistance (e.g. case benefit through CalWORKs).
