From North – Using I-580

Continue on Mountain.
Turn left onto Edwards Ave.
and downhill into 73rd Ave.
Eastmont Town Center is at 73rd & Foothill.

From North/South – Using I-880

Exit on Hegenberger, going East.
Hegenberger becomes 73rd Ave.
Eastmont Town Center is at 73rd & Foothill.

BART and Public Transportation

Eastmont Mall can be reached by AC Transit Bus Route 73 from the Coliseum BART station. AC Transit Routes 40, 57, 73, and NL stop at the Transit Center at the Mall.

- **You may enter the Eastmont Town Center off 73rd Avenue or Foothill Boulevard.**
- **Enter the Wellness Center through the Blue Arches.**
- **Continue straight past security desk down the corridor thru the double doors.**
- **The entrance to the library will be directly in front of you past the elevator.**
