Chair's Report:

- Notes that county supervisors continue to meet virtually. Items could not be voted on due to not having a quorum.
- 10x goals 2026 remain a priority as was a homeless and mental health
- Chair acknowledge the passing of Supervisor Wilma Chan in a moment of silence
- Notes that a vote is needed for the status of woman and has put forth a request the commissioner Danielson-Chang be nominated
- Chair will present harmony day and request a 200.00 check to support the program but a vote will be needed.
- Suggested having a special meeting to meet before the holidays
- Interfaith for justice would like to visit the HRC to share information

Guest Speaker:

Valarie Kane from SSA (PowerPoint presented)

- Presentation on Alameda County Workforce Development Board. Oakland has it own workforce development board
- A review of layoffs was presented and compared from 2019, 2020 and 2021
- Workforce development department has workforce service providers that pivoted to during virtual support for the community
- Online training program grew with people staying home during the pandemic
- Commissioner Mederios suggested maybe the County promoting or encouraging more people to continue doing online training programs.
- Demographics participating in workforce program equal but has a higher percentage of woman who enroll in the workforce program.
- Agency change model to narrow the scope of focus being served.
- Workforce serves youth in and out of school
- Commissioner Dwin, questions if the program can recruit students? Do you have to be an at-risk student to participate in the workforce development program?
- Chair asked if devices were provided for students during the pandemic? The Chair asked: how do youth know how to access workforce development board?
- It was acknowledged that enrollment numbers were low.
- Commissioner Dwin shared with commission that course are offered in other forms through the County.
- Workforce development gets referrals from corrections and probations
- Chair notes that between youth and adults, each program has high enrollment of women. Chair would like to know if programs are meeting the needs of women.
- Organization does not have a provider that just works with women.
- Chair mentions the importance of identifying jobs with child care and if employers are looking at the needs of mothers.
- Partnered with Facebook in a grant program to support youth in digital marketing.
- Joined forces with Goodwill to help families get laptops.
- Partnered with Fremont on a number of pathway programs.
- Formula funding has declined that makes it challenging for programing youth summer programs.
