

AN ORDINANCE REPEALING ARTICLE 5-44 OF
THE ADMINISTRATIVE CODE OF THE COUNTY OF
ALAMEDA RELATING TO THE HUMAN RESOURCES
AGENCY, AND ADDING ARTICLE 5-44 THERETO
RELATING TO THE SOCIAL SERVICES AGENCY

The Board of Supervisors of the County of Alameda, State of
California, do ordain as follows:

SECTION I

Article 5-44 of the Administrative Code of the County of Alameda
is repealed.

SECTION II

Article 5-44 is added to the Administrative Code of the County
of Alameda to read:

Article 5-44

SOCIAL SERVICES AGENCY

Section 5-44.0. RECOGNITION. There is in the County
a Social Services Agency hereinafter referred to as the
Agency. There are in the Agency a Welfare Department and
a Human Relations Department.

Section 5-44.01. EXECUTIVE OFFICER. The executive
officer of the Agency is the Director of Social Services
appointed by the Board of Supervisors.

Section 5-44.02. INTENT. Provisions of this Article
shall control over any other inconsistent provisions in
the Administrative Code. It is the intent of the Board of
Supervisors that the Director of Social Services shall
perform or cause to be performed all duties heretofore
vested in the County Welfare Director and the Executive
Director of the Human Relations Department.

Section 5-44.03. GENERAL POWERS AND DUTIES. Subject
to the direction and control of the Board of Supervisors,
and to applicable State laws, rules and regulations and
local ordinances not inconsistent therewith, the Director
shall be in charge of and responsible for the coordination
and direction of the Welfare Department and the Human
Relations Department and any other programs in the human
resources field which the Board of Supervisors may in the
future assign to the Agency.

SECTION III

This ordinance shall take effect and be in force thirty (30)
days from and after the date of its passage and before the expiration
of fifteen (15) days after its passage it shall be published once with
the names of the members voting for and against the same in The Inter-City

Express, a newspaper published in the said County of Alameda.
